As I am sure you know, KNS reports today the jury could not agree on a verdict in the Hu case. What is most concerning is that he was terminated from his position as a result of false accusations by the FBI claiming he was a spy. Noting that he reported his associations with Chinese universities to UT as part of his annual activity reports, that NASA found his research of value, and that the way we handled this case could hamper current and future linkages with Chinese universities, of which we have many, I hope the university will offer reinstatement with full back pay.
